

BOSTON MEDICAL CENTER HEALTH SYSTEM How to order a Psychiatry E-Consult in GIM/Adult Primary Care

IBH Psychiatry e-Consults will be available to GIM PCPs starting January 18, 2023.

What are Psychiatry e-Consults?

e-Consults are an inter-professional assessment performed without patient contact (i.e., based on chart review only).

- If you are looking for a one-time, direct evaluation with detailed management recommendations by a psychiatrist, please place a referral to IBH Psychiatry instead.
- If you are looking for longitudinal medication management by a psychiatrist, please place a referral to Adult Outpatient Psychiatry instead.

E-consults will be completed within 3-5 business days of request; may be able to be completed sooner on an as-needed basis.

E-consults require patient consent and may be billed to the patient's insurance company with standard patient co-pay/co-insurance as applicable.

How do I know if a patient is appropriate for Psychiatry e-Consult?

The following are examples of appropriate questions for IBH Psychiatry e-Consult:

- Medication titration or dosing question for known diagnosis (e.g., previously diagnosed ADHD; recent transfer of care to GIM)
- Alternative medication options for known diagnosis
- Adverse effect management

If you are uncertain if a question is appropriate for e-Consult, please feel free to page the IBH med pager (x0237) to check in with the IBH team.

How do I order a Psychiatry e-Consult?

1. Search for "IBH" in Orders. The e-Consult order is called *e-Consult to Psychiatry: Integrated Behavioral Health*.
